Starting 2022 the obligation of documentation and proof of recovery and recycling must be fulfilled.

The solution for the agricultural FIBCs/Big Bags lies in the short return ways at almost 400 collection points across Germany and thorough material recycling. In particular for the customers from the agricultural field a comfortable take-back service is provided by the VerenA-SYSTEM – Packaging Recovery for Agriculture (Verpackungsentsorgung Agrar) – near you.
