"How can we reduce the mountains of waste in Germany?" This question became increasingly urgent in the 1990s. Politicians found an answer to it by introducing the Packaging Ordinance in 1991. And that was precisely the starting signal for the founding of RIGK, the "Gesellschaft zur Rückführung industrieller und gewerblicher Kunststoffverpackungen mbH" [Company for the recovery of industrial and commercial plastic packaging], in 1992. Originally, we only took back packaging of non-hazardous products from industry and commerce, but we were able to expand our portfolio over the course of three decades. Today, we also take back and recycle hazardous packaging, agricultural plastics, unusable pesticides and chemicals from agriculture.


The fact that the topic of packaging take-back and recycling has a high priority throughout Europe and Germany is shown by the legislative development, which has resulted in the German Packaging Act and its amendments in Germany and in draft laws in European countries.

AMENDMENT OF THE GERMAN PACKAGING ACT

Since 03 July 2021, the amendment to the German Packaging Act (VerpackG) has been in force and brings additional obligations in the handling of industrial, transport and commercial packaging. Violations can be punished with fines of up to EUR 100,000. This makes it even more important to bring yourself up to date now and to understand and implement the new rules.
