The EU is celebrating the first birthday of its Green Deal with a new climate target: the member states want to reduce their greenhouse gas emissions by at least 55 percent by 2030. For this reason, the Commission is stepping up its previous targets by a further 15 percentage points. Climate and resource-friendly waste management is one of the most important levers for saving greenhouse gases. It is, therefore, about time we acted.

The new "plastic tax" is also putting pressure on EU countries – especially those with a flawed recycling infrastructure. These countries in particular must now quickly press ahead with closed loop recycling management transformation and launch nationwide EPR systems. Germany, with over 30 years of experience in extended producer responsibility, plays a pioneering role here. CERTIFING THE RECYCLED CONTENT OF PRODUCTS

Using the new Recycled Content Certification of RecyClass plastship can now verify the recycled content in products on the basis of the production data in a certificate. The recycling content is shown in %, as is the origin of the recyclate (pre-consumer/post-consumer). The pre-condition is that the recyclate used in production or its suppliers have an EuCertPlast certificate.
