of industrial and commercial packaging of hazardous products



As an industrial and commercial final consumer/waste producer, you can use the **RIGK-G SYSTEM** to return used packaging of **hazardous** products to any Germany-wide RIGK collection point free of charge. This packaging is conveyed to a recovery system in accordance with the terms of the German Circular Economy Act (Kreislaufwirtschaftsgesetz [KrWG]).

▶ What packaging is recovered?

The following packaging types with ADR and GHS symbols are recovered:

How does the return work?

All packaging of hazardous products that is licenced by RIGK and ideally bears a RIGK trademark may be returned via RIGK free of charge –either in a type of construction approved collection sack, in bulk or in a container. For the smooth and fast return of your hazardous packaging please contact +49 800 308600-1 or <u>g-system@rigk.de</u>. The RIGK-G-team will organize the return of the packaging under taking into account the risk classification and the location of your site.

In general, only packaging with an applied RIGK trademark can be returned. (Yet) nonlabelled packaging from fillers/distributors participating in the RIGK-G-SYSTEM can be returned on the basis of the agreement confirmation.

The packaging is assumed in compliance with waste disposal regulations as EAK waste entry 15 01 10* "packaging that contains the residuals of hazardous substances or is contaminated by hazardous substances."

Dependent on the hazard class and type of packaging, the disposal of hazardous substance packaging takes place nationwide through sanctioned reception points, treatment plants, and incineration plants. As evidence of proper disposal, the final consumer/waste producer receives a certificate of receipt or rather a recovery record that is in compliance with waste disposal regulations.

Reprocessing Groups

Packaging of **hazardous products** which due to their content are subject to labelling requirements under the law on hazardous substances and / or the law on dangerous goods and / or on the GHS is recovered. Packaging with gases, explosive, infectious and radioactive substances is <u>excluded</u> from the recovery.
